CHAIRMAN'S ADDRESS MARCH 2020

Psalm 46

God is our refuge and strength,

Yes indeed, the Lord is our refuge and strength, a very present help in trouble. Therefore we will not fear. This Psalm has been a source of strength and comfort for God's people over the ages. We only need to think of Martin Luther who penned the hymn, a Mighty Fortress, which was based on this Psalm. As we make our way through the verses we see that despite calamities that may surround us, our God commands us to be still and know that He is God. Indeed the Lord of Hosts is with us, the God of Jacob is our refuge.

It was the comfort of God's word that was the source of peace during the difficult times over the past months. It gave us the peace knowing that He would provide for a Care Manager and CEO. The assurance that our Heavenly Father is with us, is our refuge, gave us the strength that enabled us to soldier on and complete the work so that the operations of the Home would meet the requirements of the Aged Care Quality Standards. At our recent re-accreditation audit we received some very encouraging feedback, and although we do not know the outcome as yet, we were commended for the work we had done and for the way in which we provided care to our residents, or I should say consumers to be consistent with the Standards. We are thankful that the Lord has blessed the work we have done and pray that He will continue to provide us with His care and protection for the future.

I know I have mentioned it in the Chairmans report, but I want to especially thank the staff for the hard work they have done to put in place the new policies and procedures and to implement the new practices that meet the requirements of the Aged Care Quality Standards. It has been a massive undertaking and worthy of special thanks. Ladies, thankyou so much for your effort and support, and we also say thank you to your husbands and families for giving up valuable time with your wives and mothers. Thank you so much.

But we are here tonight with a revised budget for the remainder of the 2019/2020 financial year. The changes

that we needed to make in the Home have put a lot of pressure on the association's finances. We are thankful that there were reserves which could be used to cover the additional expenditure to date, but we are mindful that as an association we need to make significant changes to the way that we support our operations. The cost of providing care to meet the Aged Care Quality Standards is much higher than what we have experienced in the past. We are thankful for response we have received already from the association with big increases in contributions. It is humbling to see the love for Fair Haven and the desire to ensure that our elderly brothers and sisters are well cared for. Heavenly Father's blessing we can look forward to being able to continue to care for our aging loves ones at Fair Haven.

A lot of our focus has been on the Home but I don't want to neglect our village people. We are mindful that room is running out in the village for new units and that we need to be planning for the future. Strategic planning is still on our radar and we hope to have something for the next AGM. As you can appreciate, the activities of the past months have consumed a lot of time and energy, but we are mindful that we need to plan for the future. What will be the requirements for our village, what sort of care will we need to provide, also to people in their own homes, what can we expect by way of changes in funding from the government, what will people be expecting from aged care in the future. There are many questions that need to be asked. By planning responsibly we trust that our Heavenly Father will continue to bless us in the work we do at Fair Haven.

There is also something that weighs heavy on my heart that I need to clear up. It is regrettable that rumours have circulated concerning past staff which bring into question their reputation and character. Brs and Srs, these rumours are not only unsubstantiated, but false. I want to acknowledge in particular that Sr Dorothy van der Wal has dedicated a large portion of her life to Fair Haven which we are very thankful for but to blame to her for our failure in August is not only unfair but outright unchristian. At a recent Aged and Community Services Australia symposium I attended with our CEO, some interesting statistics were presented. Since July last year, 96% of homes that were audited had at least 1 area where they did not meet the new standards. In this way we were no different from many other homes and

KEES & JOYCE FAAS

Joyce Jeannette Rijk Faas (nee van Ommeren). They were there for the last two years of their life.

Kees was born in Axel, the Netherlands on 11 October 1939. Joyce was born in The Hague, the Netherlands on 4 March 1946. Kees and Joyce first met on 1 July 1971 whilst holidaying on the Greek island of Rhodes. Kees and Joyce were married in Amsterdam on 6 November 1971. They first lived in Eindhoven and then moved to Utrecht. They were blessed with two sons, Humphry Cornelis on 5 January 1974 and Maurits Alexander on their 4th wedding anniversary, 6 November 1975.

Joyce had the tropics in her blood, having lived with her family in Parimaribo, Suriname for most of her childhood Kees dedicated his early years in Australia to working

This is the short story of Cornelis Anthonie (Kees) Faas and life. Joyce longed for a warmer climate. Kees had also previously enjoyed a taste of the tropics, being stationed on contributors to Fair Haven from the very start, and lived the island of Biak in Dutch New Guinea whilst serving in the Dutch air force. Considering all of that, and the economic outlook in the Netherlands, the Faas Family then immigrated to Australia, arriving at Perth Airport on 7 January 1981.

> Being welcomed into the Free Reformed Church of Armadale, the Faas Family lived in Gribble Avenue (formerly Eighth Avenue) for 9 years before shifting to Tamarind Crescent in Kelmscott, where Kees and Joyce settled for almost 30 years. Kees and Joyce acquired Australian citizenship on 12 December 1985, at the same time as the Schiebaans (friends since the Eindhoven days).

diligently and obtaining the necessary qualifications to dear to them. Those who have visited the Faas Family home perform electrical work in Australia. He then worked as an electrical contractor, washing machine repairer, and welding equipment technician, until medically unable to continue full time work.

Kees could supplement his invalid pension with the occasional electrical work. However, he mostly devoted his time and energy to active volunteer roles: SES, Air Training Corp, People Who Care and St John Ambulance were some of the more prominent ones. He always stood ready to help those whose washing machines needed fixing, or needed transport or simply a listening ear. Kees had a ready smile and a sympathetic heart for other people's struggles.

Joyce dedicated her early years in Australia to caring for her husband and children, maintaining the social contact with the family back in the Netherlands, and building new friendships by being a very active sister in the Lord. Included in that were many years volunteering as a "night sleeper" at Fair Haven. Joyce also worked cleaning houses for other people, to help support her family financially.

Joyce cared a lot for a lot of people, and showed that care in many ways. A kind and encouraging word here. A small gift there. Questions of "how did it go", "are you OK", "how is so and so". And always a card for this occasion or that occasion, or just to show she loved you. Year in and year out. Seemingly without fail.

Birthday parties and other celebrations at Tamarind Crescent were always jovial affairs. Sunday evenings were often for showing hospitality over sandwiches, followed by singing from the Book of Praise. Kees and Joyce were blessed with a great group of very close friends with whom they could share both the joys and sorrows of this life. Friends that could be relied upon in good times and in bad. These many friends were a very clear and substantial blessing from the Lord.

Other people were important to Kees and Joyce and they loved to surround themselves with photos of those near and befitting fellow brothers and sisters in the Lord.

in Tamarind Crescent over the years would know the pleasure of standing in front of the huge pin up board in the hallway and recalling all of the memories recorded on the photos that Joyce had so pleasantly arranged.

Kees and Joyce shifted to a brand new unit in the Fair Haven Retirement Village in 2017. However, Joyce never really retired. Once again, Joyce transformed a building into a warm, cosy home. Joyce relished the many opportunities for easy contact with the other residents in the Village. She was often seen at the evening devotions in the Hostel, walking around visiting her friends, or keeping a good eye on the progress of the workers building the Hall next door.

Kees became unwell, and was hospitalised at the end of 2017. He never really recovered his full vitality after that. Towards the end of 2018, he began to lose weight rapidly, for no apparent reason. By early 2019 he had become frail, needing a high level of care.

Joyce cared for Kees right up to the time she was admitted to hospital on the afternoon of 2 July 2019. A diagnosis of pancreatic cancer followed soon. The Lord called her home on the afternoon of 20 July 2019.

On 4 July 2019, Kees moved into a room at Fair Haven Home, needing high level care which Joyce was by then unable to provide. Moving to the Home was very difficult for Kees. The change was from being cared for by a loving wife of many years in the privacy of very comfortable and familiar surroundings, including his belongings that had travelled with him for many years – to being confined to one room with hardly any of his belongings and being cared for in a far more public setting by many different people.

However, Kees was blessed by the love and gentle care that he could receive from the CEO, the care managers, the carers, the kitchen staff, the cleaners - all of the staff at Fair Haven. At various times, each would speak to Kees, and provide the practical help that he needed, in a manner

> The friends already mentioned earlier remained faithful and Kees received many visitors daily. During this time, Kees (and all of his family) could experience a level of genuine kindness, love and support which can only lead to one conclusion - thankful praise to our Heavenly Father for providing all that we need and more.
